Dear Mr. D'Avanzo:

The Gaming Control Board's Enforcement Division has reviewed your information regarding the game, "Big Money Blackjack – Version 2." "Big Money Blackjack – Version 2" is played using one to eight standard 52 card decks.

Your modification of the standard game of Blackjack offers new paytables to the previously approved game. "Big Money Blackjack – Version 2" allows for two optional side wagers. One of these wagers is that the player will be dealt a blackjack and the other wager is that the dealer will be dealt a blackjack. A player may make one or both of these optional side wagers.

When the "Big Money Blackjack – Version 2" side wager wins, each player and/or dealer will activate a keno type ball blower that contains 80 numbered balls and draw one ball for each side bet and/or draw one ball for all side bets. The player will be awarded a multiplier or a non-cash prize award based on the configuration and ball chosen. The enclosed paytables can be configured as follows:

- Multiplier only: Player's wager will be multiplied by the number on ball chosen.
- Non-cash prize top award with multipliers: Player wins advertised prize if ball chosen has 'prize' label. Otherwise, wager is multiplied by number on ball chosen.
- Non-cash prize top award with maximum bet: Player wins advertised prize if ball chosen has 'prize or number' label and the player has wagered the maximum amount required. Otherwise, wager is multiplied by number on ball chosen.

If the player or the dealer do not receive a blackjack, the "Big Money Blackjack – Version 2" side wager is lost.


The Gaming Control Board's Technology Division reviewed the mathematical analysis certification from a Nevada independent test laboratory. They determined that the mathematical percentages of the player payback and house advantage of the enclosed paytables are between 3.47% - 23.48% which is within the Board's required percentage hold.
